
MANUAL OF PROCEDURES

VALUATION SECTIONS (Revised to January 1st, 1941)

In Section 19a of the Act to Regulate Commerce, provision is made for the valuation of all carrier property devoted to the transportation of interstate commerce. This section of the Act also imposes upon the Interstate Commerce Commission the duty of keeping an accurate record of all improvements and changes, together with the value thereof, which are effected in the physical property of the carriers subsequent to the date as of which each property was valued.

In making and recording the valuation inventories of carrier property it was found necessary to divide each rail property into Valuation Sections, and it is very apparent that once having appraised a property by Valuation Sections, it becomes necessary to make these Valuation Sections permanent divisions of physical property in order that subsequent changes in value may be properly recorded. Accordingly, Valuation Sections have been established in each of the States in which The Denver and Rio Grande Western owns fixed physical property, and these Valuation Sections are hereby made permanent.

The purpose of this list is to thoroughly disseminate among officers and employes detailed advice as to the extent of each Valuation Section.
